Fall 2009

The undergraduate enrollment of 2,333 includes 560 new freshmen and 252 new transfer students for Fall 2009. There are 31 students classified as Post-Baccalaureate or Non-Degree Seeking. Demographically, sixty-five percent (1,518) of the undergraduates are female, and sixty-four percent (1,496) are from racial or ethnic minority groups. Students with a Baptist religious affiliation make up thirty-one percent of undergraduates.

For students with known addresses, 2,241 (97.4%) have Texas as their state of permanent address, representing 70 counties. Students from Harris, Fort Bend, and Brazoria county make up 86.8% of undergraduates. Ninety percent are U.S. citizens.

Among students who reported a high school class ranking, fifty percent were in the top quartile of their high school graduating classes. The mean score for undergraduates for the SAT is 1076 and 22 for the ACT examination.

Fall 2008

The undergraduate enrollment of 2,208 includes 560 new freshmen and 252 new transfer students for Fall 2008. There are 31 students classified as Post-Baccalaureate or Non-Degree Seeking. Demographically, sixty-five percent (1,443) of the undergraduates are female, and sixty percent (1,333) are from racial or ethnic minority groups. Students with a Baptist religious affiliation make up approximately thirty-four percent (34.4%) of undergraduates.

For students with known addresses, 2,142 (97.9%) have Texas as their state of permanent address, representing 74 counties. Students from Harris, Fort Bend, and Brazoria county make up 84.6% of undergraduates. Ninety percent are U.S. citizens.

Among students who reported a high school class ranking, fifty-one percent were in the top quartile of their high school graduating classes. The mean score for undergraduates for the SAT is 1094 and 22 for the ACT examination.

Test Score Calculations

For students with both an SAT and ACT score, only one score is counted. The ACT score is converted into the equivalent SAT score and compared to the actual SAT score, and only the higher is retained. Additionally, for students with multiple SAT test scores, the highest verbal and math subscores (from any test date) are added to get the student's final SAT score.

Prior to Fall 2007, SAT scores were reported using Recruitment PLUS. Recruitment PLUS converted all ACT scores to an equivalent SAT score, and included the converted scores in the final mean.
