Profile of Transfer Students Fall 2007 and Fall 2008

Fall 2008

The transfer students of Fall 2008 include 252 students who entered the University in Summer 2008 or Fall 2008. Selected demographic information for this group of transfer students indicate that 69% (173) are female, and that 64.3% (162) are from racial or ethnic minority groups. Students with a Baptist religious affiliation make up 33% (82) of the group.

For students with known addresses, 233 (93.5%) have Texas as their state of permanent address. Eightynine percent of the students are U.S. citizens.

Among students who reported a SAT or ACT score, the transfer class had a mean score of 1014 for the SAT and 20 for the ACT examination. Approximately 31% of students declared a major in Nursing, while 15% declared Biology, and 11% Business Administration.

Fall 2007

The transfer students of Fall 2007 include 273 students who entered the University in Summer 2007 or Fall 2007. Selected demographic information for this group of transfer students indicate that 70% (192) are female and close to 64% (174) are from racial or ethnic minority groups. Students with a Baptist religious affiliation make up 37% (100) of the group.

For students with known addresses, 260 (95.5%) have Texas as their state of permanent address. Eighty-three percent of the students are U.S. citizens.

Among students who reported a SAT or ACT score, the transfer class had a mean score of 1056 for the SAT and 20 for the ACT examination. Approximately 25% of students declared a major in Nursing, while 17% declared Business Administration, and 14% Biology.



Test Score Calculations

For students with both an SAT and ACT score, only one score is counted. The ACT score is converted into the equivalent SAT score and compared to the actual SAT score, and only the higher is retained. Additionally, for students with multiple SAT test scores, the highest verbal and math sub-scores (from any test date) are added to get the student's final SAT score.

Prior to Fall 2007, SAT scores were reported using Recruitment PLUS. Recruitment PLUS converted all ACT scores to an equivalent SAT score, and included the converted scores in the final mean.
